Applications received after the last date will not be considered.

4. For each of the qualifications, professional experiences, achievements, etc., documentary proof in the form of self-attested photocopies is to be attached with the application.
5. The originals must be produced at the time of interview/written test and at the time of joining.
6. Incomplete applications / applications without necessary enclosures may not be accepted.
7. Any misleading / wrong information supplied by the candidate may lead to rejection of the application summarily, if found subsequently, also the appointment will be cancelled.

8. Mere fulfilment of required minimum qualification and experience for the post does not entitle the candidate to be called for interview.
