**Welcome note**: At the outset, the Chairman welcome all the members present in the 9<sup>th</sup> meeting of the Board of Governors of the institute.

Then agenda items were then taken up and the following resolutions were adopted.

Item No. 1: Confirmation of minutes of the 8th BoG Meeting held on December 04, 2023.

**Resolution:** There being no comments made on the minutes of the 8<sup>th</sup> BoG Meeting held on June 27, 2024, excepting the one by the Ministry of Education, which was taken up against the action taken report, the same was confirmed.

Item No. 2: Action taken report on the resolution of the 8th BoG Meeting Itemized vide Supplementary Agenda).

a. Action: To write to Department of Expenditure, Ministry of Finance for obtaining specific approval or exemption while creating adequate number of Faculty positions at IIIT Kalyani – Further Action Taken

The BoG noted that necessary action has already been initiated in this regard and communications from the end of the institute have already been made with the Department of Expenditure, Govt. of India in the month of August, 2024 with follow up communications in the month of October and December 2024. Also noted that the institute is yet to get a response from the Dept. of Expenditure, Govt. of India.

Comments received from the Ministry while confirming the agenda – "MoE is not releasing funds to IIITs (PPP) under OH-36, they may be allowed to create posts as per their



requirements and IRG position. We have already permitted some other IIITs (PPP) recently for creation of posts based on this."

#### b. Action: Matters related to Grievance Redressal Committee

The Board noted that the minutes of the 2<sup>nd</sup> meeting of Grievance Redressal committee was circulated amongst the members of the BoG and the Registrar, IIIT Kalyani was appointed as the Convenor (non-member) of the said committee.

Comments received from the Chairman, Rolta Foundation, while confirming the agenda – "Please refer to item no. 2 (b), as the Grievance Redressal Committee consists of Dr. Uma Das who was Director of BOG but now is being replaced by another member of faculty as per item no. 11. Therefore, I suggest that in the next meeting one or two new faculty members should be nominated as the member of Grievance Redressal Committee by the Board in place of Dr. Uma Das."

#### Item No. 3: Director's reporting.

**Resolution:** The Director apprised the BoG about the current status in the permanent campus construction of the institute. Both physical and financial progress were reported. The flow of funds in non-recurring and recurring heads was enumerated. The Board was further apprised that IIIT Kalyani was able to create a corpus fund of Rs. 5.05 Crore and another Corpus against the Sponsored Research and Industrial Consultancy (SRIC) head against a fund of Rs. 11.21 lakhs.

The BoG as per the letter received from the CPWD dated 25.10.24 (Annexure – VI of the agenda) noted that the taking over of the campus and dedication/inauguration of the campus may be made in February 2025 provided CPWD gets adequate support from the local municipality.
