**About the Institute:** Set up in the year 2014, IIIT Kalyani is one of the 25 IIITs established by the Ministry of Education, Government of India, under the *Not for profit Public Private Partnership* (N-PPP) model. A Memorandum of Understanding (MoU) was signed between the Government of India, Government of West Bengal, and three Industry Partners, namely, Coal India Limited, Rolta Foundation, and WBEIDC Ltd. (Webel) for setting up the institute at Kalyani, with the stakes of the partners at a ratio of 50:35:15 respectively. The institute has been declared as an *Institute of National Importance (INI)* as per *The Indian Institutes of Information Technology (Public-Private Partnership) Act, 2017*. The institute has been mandated to produce best-in-class human resources in IT and to harness the multidimensional facets of IT in various domains. IIIT Kalyani strives to evolve into a world-class academic institution with the highest education and research facilities and produce industry-ready IT graduates to meet the industry demands. The institute aims to act as a catalyst in fostering an innovative ecosystem to ensure that new products, solutions, and innovations are created, taking advantage of the state's intellectual capital. IIIT Kalyani offers semester-oriented undergraduate and research programs to impart high-quality science and engineering education. Admission to the academic programs is synchronized with the academic year and occurs according to the procedure laid down by JoSAA and CSAB (for UG level). IIIT Kalyani offers a Doctoral program in the areas of *Computer Science and Engineering, Electronics and Communication Engineering, Mathematics and Physics*. It has recently started a fully online *Executive M.Tech Program in Artificial Intelligence and Data Science*, for the working professionals. IIIT Kalyani aims to excel in education and research in Information Technology and allied areas. The institute is committed to providing state-of-the-art technical education in information technology and catalysing transmission of knowledge using the latest developments in pedagogy. While the construction work for the permanent campus has been initiated, the institute is presently operating from its temporary campus at WEBEL IT Park Kalyani, West Bengal.

**Reporting for Admission:** Reporting can be done either **online** or in **physical** mode.

#### **Online Reporting:**

1. Download [Admission Form](#) and fill it up.
2. Make a single PDF file using the scanned copy of filled in admission form, copies of the following. Name the file as **<Candidate's Name>-<JEE-Main application number>-Form.pdf**.
  - a. Aadhaar Card
  - b. Document Verification-cum-Seat Acceptance Letter.
  - c. Admit Card of JEE (Main) 2023.
  - d. Score/Rank Card of JEE (Main) 2023.
  - e. Class X Marksheet and Certificate.
  - f. Class XII (or equivalent) Marksheet and Certificate.
  - g. Certificate of Category (SC/ST/OBC-NCL/GEN-EWS), if applicable, as per JoSAA 2023 format, issued by the competent authority. For OBC-NCL/GEN-EWS, certificate must be issued on or after April 01, 2023.
  - h. Certificate of PwD, if applicable issued by the competent authority, as per JoSAA 2023 format.
  - i. Medical certificate as per JoSAA 2023 format given in [Annexure 7](#).
3. Make payments of Academic Fee and Hostel Fee (Optional).
4. Make a single PDF file using the downloaded payment receipt(s) – *Academic Fee* and *Hostel Fee*. Name the file as **<Candidate's Name>-<JEE-Main application number>-Payments.pdf**.
5. Send the two PDF files by mail to [admission@iiitkalyani.ac.in](mailto:admission@iiitkalyani.ac.in) with subject line as "B.Tech. Admission 2023: <Candidate's Name>-<JEE-Main application number>".
6. Put the two PDF files into a ZIP folder and upload in this Google Form: <https://forms.gle/RpwcSBadKw7CrZ8P7>.
7. Confirmation of reporting will be sent over mail.
8. Hardcopy admission form along with all documents to be submitted when the candidate reaches IIIT Kalyani physically.

#### **Physical Reporting:**

Similar to online reporting, however, all documents are to be submitted along with payment receipts, to the institute.

### **Anti-Ragging Declaration:**

All students admitted to IIIT Kalyani will need to complete the anti-ragging declaration formalities. The procedure to be adopted for the same is as follows.

1. Submit details on the website <http://www.antiragging.in>.
2. Read and confirm that the student and parents/guardians have read and understood the regulations on curbing the menace of ragging. Confirm and agree that the student will not engage in ragging in any form.
3. An Email will be received by the student mentioning a *registration number*. The registration number has to be written while filling the Admission Form, Page 5. A web link will also be received by the student. The link should be forwarded to the institute mail id, [antiragging@iiitkalyani.ac.in](mailto:antiragging@iiitkalyani.ac.in).
4. Details needed to be submitted at anti-ragging website are given below.

5. Once the form has been filled, download, print and sign (i) Student's Anti-Ragging Undertaking and (ii) Parent's Anti-Ragging Undertaking from the Anti-ragging website.
6. The signed undertakings are to be submitted to IIIT Kalyani office at the time of joining the institute physically.
