Ph.D. Admissions 2020-21 (Even Semester)

Applications are invited from eligible Indian Nationals for admission to the Doctor of Philosophy (Ph.D.) programme in even semester, 2020-21. This programme will be offered in Computer Science & Engineering (CSE), Electronics and Communication Engineering (ECE), and Physics (Space and Atmospheric Sciences). Admissions are offered in the following categories:

i)External: A student in this category is a scholar employed in an R&D organization/academic institution/industry having adequate research facilities. The research work leading to the Ph.D. degree may be carried out largely in the parent organization of the candidate under a Local Supervisor from the organization but with the overall guidance provided by a faculty member (Institute Supervisor) of the Department/Centre in which he/she is registered. Such a candidate will have to complete the course work and other requirements of the Institute and will have to take official withdrawal after completion of the requirements to continue work in his/her parent Institute. The Institute will not provide any assistantship/fellowship to such a student.

ii) Regular

A student in this category works full-time for his/her Ph.D. degree. A candidate already with a provisional Ph.D Fellowship offer (CSIR/UGC NET/any other Fellowship) can apply in this category.

iii) Sponsored (full-time)

A student in this category is sponsored by a recognized R&D organization, academic institution, government organization or industry for doing research in the Institute on a full-time basis. She/he must be a regular employee of the sponsoring organization with at least one year of professional experience in the respective field. The Institute will not provide any assistantship/fellowship to such a student. Sponsorship letter must be attached with the application.

iv) Part-time

A student in this category is a professionally employed person, who pursues the Ph.D. Programme while continuing the duties of his/her service. A 'No Objection Certificate' from the Head of the Institution/Organization (if applicable), in which he/she is employed, must be enclosed/to be produced at the time of test/interview.

ELIGIBILITY CRITERIA

For admission to the Ph.D. Programme in various disciplines a candidate must satisfy the following criteria:

i) CSE

Master degree in Engineering/Technology in the relevant area (CSE/IT/ECE) with a minimum CGPA of 6.5 in 10 point grade scale or 60% of marks, GATE score is preferable.

ii) ECE

Master degree in Engineering/Technology in the relevant area (ECE/CSE/IT) with a minimum CGPA of 6.5 in 10 point grade scale or 60% of marks, GATE score is preferable.

ii) Physics (Space and Atmospheric Sciences)

(a) Post Graduate Degree in Basic Science (Physics/Mathematics/Computer Science/ Electronics) or Graduate degree in Professional Course or equivalent with minimum of 60% marks or equivalent **and** CSIR-UGC-NET-JRF or CSIR-UGC-NET-LS or GATE or JEST or JAM qualification (as per OM No. SB/S9/Z-01/2015, Govt. of India).

or

(b) M. Tech. with min. of 60% marks or equivalent (as per OM No. SB/S9/Z-01/2015, Govt. of India).

Mere fulfilment of eligibility criteria does not ensure an applicant's right to admission in the Ph.D. programme. The decision of the IIIT Kalyani will be final in this regard.

Reservations will be applicable as per MHRD, Govt. of India norms.
